Holland further noted that Ben and Howard participated in meetings with Moncus Park, UL Lafayette, One Acadiana, DDA & DLU Board leadership, and Lafayette Consolidated Government.

Trahan read the resolution into the record.

CEO Report

Begnaud noted that the Old Federal Courthouse has opened a leasing office Downtown. Buchanan Parking Garage and Vermilion Parking Garage repairs will be complete by year end. Begnaud noted that October collections of the Downtown EDD were up from previous month with \$53,700 in collections. Begnaud noted she and Holland have been working with Sam Oliver of the ACA to put forward a Downtown site for study for the Proposed Performing Arts Center. Begnaud noted that DDA and DLU have historically help assemble property and lead the design process to locate cultural facilities and public parks Downtown. Begnaud further noted she and Holland have been working with Waggoner & Ball to coordinated with LCG drainage team on research, study, and work done to date. Begnaud noted that they are planning a visit immediately after the Christmas Holidays.

RESOLUTION 9 DECEMBER, 2021

WHEREAS, the Lafayette Centre Development District d/b/a Downtown Development Authority, a political subdivision of the State of Louisiana ("DDA"), has a mission to formulate a redevelopment plan or plans for the district and submit such plan to the city council for review and approval. The authority shall formulate a program or programs to implement any redevelopment plan so approved by the council. Such a program shall implement the various plans in such a manner as to aid and encourage private development of the area and to promote and coordinate public development. In formulating such program, the authority may conduct studies and may consult with all departments of the city of Lafayette and other public or private agencies concerned with matters affecting or affected by the program. After approval of a development program, the district may then implement any portion thereof in such manner as shall in the judgment of its governing authority most likely accomplish said program. To that end, the district may employ engineers, architects, attorneys, underwriters, and other professionals necessary for financing and implementation of the construction, renovation, maintenance or operation of facilities described in the redevelopment plan and may contract but in accordance with law for the construction, renovation, and maintenance, or operation of the facilities;

WHEREAS, Downtown Lafayette Unlimited, Inc. ("DLU"), a non-profit Louisiana corporation, has a mission to establish a permanent promotional program pointed towards a progressive and dynamic central downtown Lafayette; to preserve and expand central downtown Lafayette as a regional business and shopping area for the general benefit of the metropolitan area of Lafayette, and

its surrounding markets; to cooperate with all members of the corporation through group action on

common problems, and to cooperate with the City Council of the City of Lafayette, the Lafayette

Parish Police Jury or Parish Council, other governmental bodies, civic organizations, and other

interested groups or individuals, in solving the civic, business and commercial problems of the City

of Lafayette; to alleviate parking problems and other problems resulting from congestion; to improve

the appearance of the central downtown area; and generally to promote, aid and assist in development

a better central downtown Lafayette for the use and benefit of everyone, and to do any and all things

necessary and with full authority to perform all acts necessary or proper to accomplish purposes

expressed or implied in said articles, or that may be incidental thereto;

WHEREAS, the Chief Operating Officer of the DDA is also the Chief Operating Officer of

the DLU and, further, the DLU has two (2) designated seats on the Board of Directors of the DDA;

WHEREAS, the mission and existence of the DDA and DLU are functionally identical and

the historic relationship of the DDA and DLU have been, and will continue to be, both by nature and

in function, symbiotic;

WHEREAS, the DDA and the DLU desire to memorialize their procedural and substantive

relationship.

NOW, THEREFORE, BE IT RESOLVED that the DDA does and hereby agrees to

enter into the Cooperative Endeavor Agreement annexed hereto and does further authorize its

Chairman, Greg Walls, to execute the subject agreement on behalf of the DDA.
