## Administrative Approvals/Reports

## CUP: 522 Jefferson

Holland noted that 522 Jefferson is seeking a conditional use permit for a speakwasy bar concept with a capacity of 49. Holland further noted that they will be allowing age 21 and older admintance.

Walls motioned to recommend 522 Jefferson for a CUP permit, Chappuis seconded, all voted in favor.

## Resolutions

Centanni motioned to approve a Resolution of the Board of Directors authorizing negotiation of cooperative endeavor agreement on behalf of the Downtown Development Authority with Downtown Lafayette Economic Development District to reimburse up to \$20,000 for Railroad Area Redevelopment planning match with LPTFA, Skinner seconded, all voted in favor.

Centanni motioned to approve a Resolution of the Board of Directors authorizing negotiation of cooperative endeavor agreement on behalf of the Downtown Development Authority with Downtown Lafayette Economic Development District to reimburse up to \$25,000 for planning and design services associated with landscaping along Jefferson Street, Chappuis seconded, all voted in favor.

Centanni motioned to approve a Resolution of the Board of Directors authorizing negotiation of cooperative endeavor agreement on behalf of the Downtown Development Authority with Downtown Lafayette Economic Development District to reimburse up to \$25,000 for planning and design services associated with public plaza along Parc Sans Souci, Skinner seconded, all voted in favor.

Centanni motioned to approve a Resolution of the Board of Directors authorizing negotiation of cooperative endeavor agreement on behalf of the Downtown Development Authority with Downtown Lafayette Economic Development District to fund \$200,000 for the planning, design, and installation of Public Space Fundamentals: including streetscape elements, gateway features, lighting, pedestrian safety features, landscaping, hardscaping, planters, bollards, drinking fountains, trash receptacles, street furniture, and public art, Skinner seconded, all voted in favor.

Chappuis motioned to approve Resolution of the Board of Directors revising the Vehicle Allowance Policy, Skinner seconded, all voted in favor. Blanchard noted that his vehicle is a Ford Bronco.
